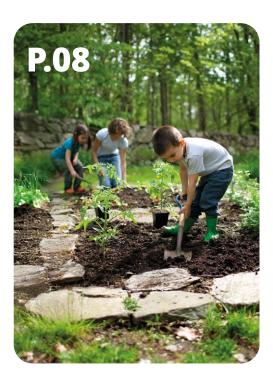

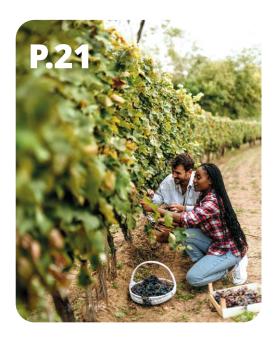

It is through concrete action, listening, and dialogue that we can create ambitious, realistic, and shared responsible investment goals. •

n a world that is undergoing profound transformation, where climate, social, and economic challenges are intertwined, the finance sector has an important role to play in facilitating the transition to a more sustainable economy. At Amundi Alternative & Real Assets, we are convinced that this collective ambition is rooted in real engagement with the companies we support. This engagement, which is at the heart of our strategic decisions, feeds our conviction: it is through concrete action, listening, and dialogue that we can create ambitious, realistic, and shared responsible investment goals that drive the long-terme development of companies.

This approach is based on one simple requirement: to be pragmatic without compromising on our ambitions. Through Real Estate, Private Equity, Infrastructure, Private Debt, Multi-Manager Private Markets, and the Alternative funds platform, our teams support companies in defining credible, tailor-made ESG roadmaps that are consistent with their operational reality. This is what we call the "direct shorthand" for ESG. We know that investor's support is essential, but it is not enough. The transition to a sustainable economy also requires a clear framework, strong policy incentives, and the mobilisation of all stakeholders. It is through this dialogue, by being both steady and committed, that we can truly advance standards.

Non-financial analysis is at the heart of our approach. As with our financial analysis, we ensure that it is based on a rigorous methodology that can inform decision-making at all levels. This means meeting a major challenge: the quality and comparability of data. Too often, the information available remains fragmented, heterogeneous, or not standardised enough. We support our investments on a daily basis in an effort to make this data reliable and complete, based on tools that facilitate the collection and use of the data collected. This rigorous process is also reflected in our investment solutions. In private

debt, for example, the development of Sustainability-Linked Loans (SLLs) makes it possible to align financing conditions with credible and measurable ESG commitments, thus encouraging companies to accelerate their decarbonisation pathway.

These initiatives are part of an ambitious ESG strategy that was recognised in June 2024 with Private Equity Magazine's ESG Sustainable Development Award. This recognition underscores our ability to harmonise our practices, to pool our tools and approaches across our areas of expertise, and to grow a responsible offering in all our businesses and locations, which are now fully integrated into our operations.

The year 2024 was also marked by major milestones: the integration of Alpha Associates, a multi-manager recognised for its committed ESG practices; the continued transformation of Amundi Real Estate's portfolio towards greater sustainability and resource efficiency; the launch of Alpha Global Infrastructure II, an SFDR Article 8 infrastructure fund-of-funds; as well as the deployment of an offer accessible to individual investors with the Amundi PRIMA program.

At the same time, we are fully committed to leading institutions - through France Invest, Observatoire de l'Immobilier Durable (OID), Association Française des Sociétés de Placement Immobilier (ASPIM), L'Institut de la Finance Durable, ESG working groups on private debt and private equity - to share our methods, set the standards, and further develop our own practices. This contribution to the governance of our industry, in which our teams participate on a daily basis, reinforces our conviction that responsible finance progresses through cooperation.

In an international context where ESG approaches are sometimes debated, our ambition remains unchanged. Climate change, pressure on resources, and shifting societal expectations are all unavoidable realities. These can all be opportunities for transformation, innovation, and long-term value creation. We are convinced that companies that fully account for these challenges will be the most resilient, and prove to be those that succeed tomorrow.

Our ambition for 2025 addresses these challenges: establish a carbon footprint for 100% of our investments*, refine key ESG indicators, and increase the ESG buy-in of all stakeholders - employees, managers, shareholders. Responsible finance cannot simply be declared; it must be demonstrated and measured on the ground, in each project, at each stage. This is how it will become, more than ever, a lever for lasting sustainable transformation.

Diversified, agile, and deeply committed, Amundi Alternative & Real Assets (ARA) places the openness and accessibility of private markets at the heart of its mission. Our teams bring together complementary expertise across Alternative & Real Asset classes: Infrastructure, Real Estate, Private Debt, Private Equity, Multi-Manager Private Markets, and Alternative Assets. In April 2024, we acquired Alpha Associates, allowing us to expand our offering by combining direct investment expertise, funds-of-funds, and selection of third-party managers. In addition, we have added a new alternative expertise: hedge funds. This multi-sector expertise is based on a shared methodology that allows us to cover a wide range of opportunities and is underpinned by a common ESG analysis framework.

ince Amundi's adoption of the Principles for Responsible Investment (PRI) in 2006, and even more so as part of the "ESG Ambitions 2025" plan, we have taken environmental, social, and governance (ESG) factors into account in all our investment processes, from pre-investment analysis to the monitoring of portfolio assets and their exit. This commitment is reflected in every fund, such as the launch of the FCPR Amundi Infrastructures Transition Énergétique and the "Amundi PRIMA" investment strategy, designed to make real assets accessible to as many people as possible. We are also broadening our investment approach through strategic alliances, such as our partnership with Investindustrial, a major investment manager in Europe.

These projects, described in the following pages, illustrate our ability to **combine transparency, innovation, and methodological rigour.** Being a responsible investor is not just a statement: it is a daily action, anchored in our DNA at the heart of every decision.

Thanks to the expertise of our teams, value-added partnerships, and the integration of Alpha Associates, ARA strengthened its investment solutions' offering in 2024. All of the solutions are designed to combine performance and responsibility, in alignment with our goals as a responsible investor. In this section, we are happy to present some of our recent projects.

INFRASTRUCTURE

Alpha Global **Infrastructure II:** first fund launched by the newly established **Amundi Álpha Associates** business line

 Alpha Global Infrastructure II, an SFDR Article 8 fund launched in Zurich, is a sign of the successful integration of Alpha Associates and the ongoing collaboration between our Swiss and Paris offices.

The fund of funds invests in top-tier infrastructure managers with strong ESG credentials that focus on North American and European Core and Core + brownfield² assets with existing cash flows and established operations assets. Aimed at institutional investors, Alpha Global Infrastructure II successfully held its first closing in September 2024. This was followed by the completion of its first two

investments: a commitment to a North American fund manager, targeting Core and Core + assets in OECD countries, and a direct co-investment into a French fibre optic provider. With access to a broader set of relationships with best-in-class managers, enabled by the combined networks of the Paris and Zurich teams, Alpha Global Infrastructure II's portfolio construction continued apace in 2025.

Alpha Global Infrastructure II is an SFDR Article 8 fund launched in September 2024, following the acquisition of Alpha Associates by Amundi in April 2024. We're proud of the collaborative work that contributed to this launch and our combined investment expertise, which we believe will lead to many significant projects in the future.

MULTI-MANAGER PRIVATE MARKETS

Amundi Partners Investindustrial Private Equity, a partnership of two experts



In 2024, ARA formed a strategic partnership with Investindustrial, a globally recognised player in Private Equity, thereby creating the Amundi Partners Investindustrial Private Equity fund.

This partnership provides access to a private equity strategy usually reserved for institutional clients, enabling investment in small and medium sized enterprises (SMEs) in southern Europe that are leaders in their local market and showing domestic or international growth potential. Focusing on manufacturing, FMCG (Fast Moving Consumer Goods), healthcare, and technology, the strategy is invested in key sectors of the real economy. Classified as SFDR Article 8, this fund is co-managed by two proven management companies, allowing clients to diversify their investments while supporting the economic development of Southern Europe.

HEDGE FUNDS

Hedge funds - Amundi Marathon Emerging Markets Bond Fund: converted into an SFDR Article 8 fund in 2024, it now incorporates the JP Morgan ESG Emerging Market Bonds Global Diversified Index. This index allows it to measure its ability to generate alpha and outperform the new benchmark index.

Democratising access to alternative assets

ARA is committed to making alternative assets more accessible to all types of investors, by designing tailored investment solutions and providing expert support. This commitment is part of an ongoing approach that emphasises high sustainability standards and education on ESG criteria.

MULTI-MANAGER PRIVATE MARKETS

Amundi PRIMA, an evergreen solution for greater access to private markets

Launched in 2024, Amundi PRIMA is fully in line with ARA's commitment to democratise access to private markets for individual investors.

This European Long-Term Investment Fund (ELTIF), classified as SFDR Article 8, stands out for its evergreen³ format, which has no predetermined end date and offers investors greater flexibility to invest and exit at any time4. Designed to meet growing market demand, Amundi PRIMA offers a diversified portfolio in terms of asset classes, focused on financing major transitions - ecological, societal, territorial, and digital - across sectors such as renewable energies, biotechnology, and smart cities

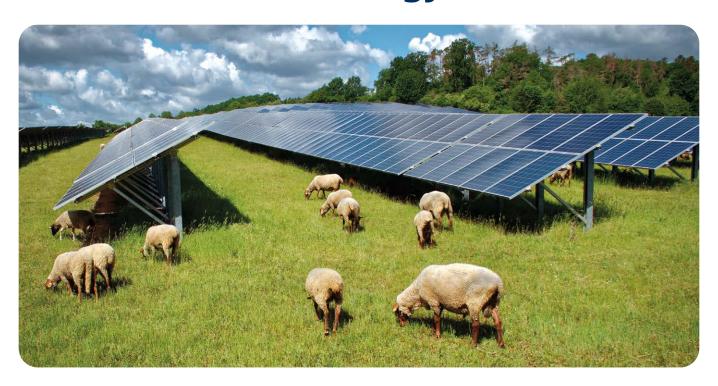

INFRASTRUCTURE

Opening up the energy transition to individual investors, with ZE Energy



Amundi Infrastructures Transition Énergétique (AITE) has led a €54 million fundraising operation for ZE Energy.

As an independent producer of Battery Energy Storage Systems (BESS), the company develops hybrid solar power plants combining photovoltaics and batteries, tailored to the needs of the European market. The energy produced is sold either directly to consumers or through tenders. This fundraising will help finance its European expansion over two years. With a portfolio of projects totalling more than 1 GW of solar photovoltaic and more than 400

MW in batteries, it aims to have an installed capacity of 900 MW of solar panels and 600 MWh of storage by the end of 2026. For Amundi Transition Energétique (ATE), this transaction is in line with its Core + investment strategy, which combines asset strength and environmental innovation. It also embodies the goal of the AITE⁵ fund, which is classified SFDR Article 9: to open up concrete opportunities in the energy transition for individual investors.

We believe in the potential of hybrid solar infrastructure with storage, which is a key driver for decarbonising the electricity system.

Launched in 2023, the AITE (Amundi **Infrastructures Transition Energétique)** fund allows individuals to invest in concrete and sustainable projects such as renewable energies, smart grids, and energy efficiency. In this joint interview, **Bruno Ducastel (Director of Network Development and Distribution for Real** Assets) and Guillaume Lecuyer (Director of Operations and Asset Management at Amundi Transition Énergétique) discuss the fund's genesis, the challenges encountered and their ambitions for the coming years. This is a prime example of the combination of expertise and openness in the service of responsible investment.

• What is AITE? How did this project come about?

Guillaume Lecuyer — AITE was born out of a strong ambition: to create an impact fund dedicated to the energy transition that would be accessible to the general public. It took nearly three years of work, because we had to build everything from scratch: obtain approvals, define the framework, and structure the offer. We wanted to give individual investors access to the same quality of assets as institutional investors.

Bruno Ducastel — There was real demand from clients. In the wake of the energy

crises, individual investors were very receptive to the idea of using their savings to support the energy transition. We therefore designed an SFDR Article 9 impact fund exclusively dedicated to assets that contribute to carbon neutrality.

• How does it enable individuals to participate in the energy transition?

G.L. — It's a real democratisation process: AITE gives access to tangible assets – such as those of ZE Energy (p.12) – which were previously reserved for institutional investors. It fits perfectly into a long-term savings strategy with a moderate level of risk, suitable for individuals.

B.D. — We have developed an educational message based on three main pillars: renewable energies, energy efficiency solutions and mobility solutions. Financial institutions acting on behalf of their clients have taken ownership of the subject, and the fund is now listed in the main life insurance contracts, notably at Crédit Agricole Assurances in France.

What makes this fund innovative?

B.D. — AITE is the first infrastructure fund to be distributed on a large-scale through our networks. Its structure, accessibility and target performance - around 8%6 net - make it a differentiating product.

G.L. — Its structure also makes it innovative. We have shortened the funds lifespan to eight years, with possible extensions. This allows us to be more in tune with the expectations of individuals, compared to 15 or even 25 years for institutional vehicles. Access has been simplified: life insurance, securities accounts, PEA-PME (small and medium-sized company equity saving plans), etc. We have also set up rigorous monitoring of the impact, both in terms of carbon emissions avoided and in terms of governance and biodiversity.

What are your prospects?

B.D. — With more than €20 million raised in one year, we have validated this market's interest. This is a very good outcome for a clientele that is new to this type of fund. The fund runs until March 2026, and we are entering an acceleration phase. The goal now is to double this momentum, particularly by gaining visibility among customers and networks.

G.L. — The next big step will be the development and marketing of a similar vehicle dedicated to private banking clients. It will offer an ad hoc digital solution with refined performance management. This will be a natural evolution of the AITE model.

lose to decisions and at the heart of the action, real assets are the direct "shorthand" for ESG of the real economy. By supporting local businesses, job creation, and reindustrialisation, we are working towards sustainable and inclusive growth. ARA's strength lies in its close ties with companies and assets. Thanks to this direct link, we have detailed knowledge of their ESG data, their operational challenges, and their ability to transform. This approach allows us to monitor, measure, and guide their progress in a demanding and constructive way. Our commitments are concretely reflected in emblematic projects such as our participation in the TIBI initiative⁷ for the Amundi Private Equity Transition Juste fund, or our partnership with the Swiss NGO Myclimate8. Ecological innovation is also at the heart of our selection of assets, as evidenced by our investments in the company Algo Paint, or in the Bois des Saulx wind farm, alongside Opale Energies Engagées. Honoured with the "ESG Sustainable Development" award by Private Equity Magazine, and other distinctions such as the renewal of the SRI label for our Real Estate expertise, our approach demonstrates that it is possible to be ambitious while giving meaning to our investments.

Time for action

PRIVATE DEBT

Amundi Ambition Agri Agro, the alliance of science and finance

Launched in December 2023, the Amundi **Ambition Agri-Agro Direct Lending Europe** fund finances the sustainable transition of Europe's carbon-intensive agriculture and agri-food sectors. To structure this approach, an independent scientific committee has been set up.

Bringing together leading academic and sector experts, it informs the fund's decisions through a rigorous analysis of the sector's environmental and economic issues. Its mission: objectify the monitoring of impacts, to manage a strategic watch on transitions and to open up new perspectives, particularly in terms of biodiversity. An initiative that reflects ARA's philosophy: to exchange views and rely on scientific and field experts to ensure that each investment is part of a measurable and sustainable performance trajectory.

By bringing together expertise from different backgrounds, ranging from agriculture to academics, within its scientific committee, the fund is asserting its position as a pioneer. During these committees, these different perspectives can help to strengthen the analysis of key trends and identify opportunities for transition, such as the most relevant levers of impact, for the agri-food industry and in the service of sustainable investments.

The Bois des Saulx wind farm supporting the energy transition



 In May 2024, Amundi Transition Énergétique (ATE) inaugurated the Bois des Saulx wind farm, alongside Opale Energies Engagées, a recognised player in renewable energies.

Born from a strategic partnership signed in 2020, this project, in which Amundi is an 80% co-shareholder, illustrates ATE's commitment to supporting industrial players working towards a decarbonised energy mix. With its six wind turbines, the farm produces 18 MWatt, equivalent to the consumption of 18,000 people, and avoids the emission of 22,000 tons of CO2 per year. By way of comparison, the average annual emissions of a French person amount to 9.2 tons of CO₂. This wind farm embodies ATE's commitment to contribute to France's energy autonomy and to promote an ecological transition rooted in the regions.

One of the most significant achievements of 2024 was the FPCI Amundi Private Equity Transition Juste receiving not one, but two labels, TIBI and Greenfin. This double award, in a complex period for sustainable funds, illustrates ARA's ongoing commitment to ESG. Laurence Laplane-Rigal and Antoine Darodes look back on this ambitious project with a confident outlook.

We have succeeded in building an exemplary fund, precisely the type of vehicle in which we like to invest.

LAURENCE LAPLANE-RIGAL

What is the Amundi Private Equity Transition Juste fund and how does it fit into an impact investment approach?

Antoine Darodes — This SFDR Article 9 impact fund was launched in 2024 by Amundi in partnership with the French Banque des Territoires. It meets the most demanding standards of European regulations. In fact, it pursues a dual objective: to generate both financial and extra-financial performance. In practice, it has already made three investments in SMEs and mid-cap companies that are developing solutions to decarbonise the most polluting sectors: Ecoparts, specialised in the sale of spare parts for household appliances; Intent Technologies, a cloudbased building data management platform; and Faume, a second-hand platform focused on fashion and luxury goods (2025).

Laurence Laplane-Rigal — This fund also stands out for its comprehensive approach, since it supports companies through every stage of the implementation of these solutions and every aspect of their transition, including the social dimension, which is often overlooked.

What do you take away from this collaboration?

A.D. — We have been working with the Amundi teams for a long time, but this project stood out for its co-construction approach. This dynamic enabled us to gradually design a successful product, supported by a rigorous and robust impact methodology that is perfectly aligned with our convictions.

Almost a year after the fund was launched, what results have been achieved?

L.L.R. — Despite a challenging economic environment, we made two investments in 2024 and one in early 2025. These transactions reinforce our belief that vehicles such as the FPCI Transition Juste remain essential to support companies in the ecological and social transition.

This fund has been awarded the TIBI and Greenfin labels. What is the impact of these distinctions?

L.L.R. — Obtaining these two labels demonstrates the high level of requirements applied to the selection and composition of the portfolio. The TIBI label aims to steer more investments towards sustainable finance. The second label, Greenfin, is issued by the French Ministry for Ecological and Solidarity Transition which promotes funds that contribute to the ecological transition and climate action. Beyond their symbolic significance, these recognitions strengthen the fund's credibility and encourage investors to raise funds.

What are the objectives for this fund in 2025?

A.D. — We have three priorities. To support the three companies already in the portfolio, to continue rolling out the fund, with a potential fourth investment to come, and finally to continue the fundraising with a target closing date in 2025.

Committing to more inclusive and resilient territories

As the economy of tomorrow takes shape, social inclusion, individual autonomy and resource sustainability are becoming major challenges for European regions. ARA is supporting this transformation by backing innovative projects that strengthen social ties, facilitate access to suitable housing and promote the sustainability of consumer goods. True to our commitment to responsibility, we invest in concrete, useful solutions.

PRIVATE EQUITY

Ecoparts: repair to last

In 2024, ARA invested €8 million in Ecoparts (formerly SOS Accessoire), a specialist in household appliance self-repair through the online sale of spare parts to individuals.

Carried out through the Amundi Private Equity Transition Juste fund, this investment has consolidated the company's position in the markets serving both individual customers and repair professionals.

With nearly 300 employees and a turnover of €120 million, Ecoparts plays a key role in the circular economy. Each year, its activity prevents the emission of more than 25,000 tons of CO₂, which is as much as the average annual CO₂ emissions of nearly 2,720 French citizens.

By helping to extend the life of domestic appliances, this investment responds to the new challenges of sustainable consumption, while promoting local employment and equipment sustainability.

 In 2024, ARA renewed its commitment to Résidences Comme Toit, investing €6 million through its Amundi Finance & Solidarité fund.

This support helps consolidate this innovative model of inclusive housing, combining adapted housing and 24/7 home care services. Already present in Montigny-lès-Metz (French town in the northeast of France), the initiative is being rolled out with six new projects under construction in 3 different French Regions. Ultimately, Résidences Comme Toit aims to develop around a hundred projects across France, to meet the growing need for adapted housing for people with disabilities or loss of

autonomy. This investment illustrates Amundi ARA's commitment to local solutions with a strong social impact.

The ESG Sustainable Development Award, recognising collective commitment

Why did you apply for Private Equity Magazine's ESG Sustainable Development Award?

Lorna Lucet — This award was a natural choice as it matches with our asset class and reflects the scale of the efforts made by our teams as well as the companies we support. Beyond the award itself, this distinction positions us among the major players in the sector, fully legitimising our place among the funds most committed to ESG issues.

Claire Chabrier — This award also symbolises the end of an initial cycle of ESG structuring, marked by the implementation of an organisation, methodology and procedures that are now fully integrated. In addition, it acts as a differentiating marker in relation to our peers, and sends a strong and reassuring signal both internally, to our clients and to our portfolio companies.

What were the key drivers behind this award?

C.C. — The first lever is our ambitious ESG policy. One of the cornerstones of our approach is the place that ESG occupies within our governance. For example, ESG is represented on the PEF Midcap investment committee and has veto power when it comes to final decisions. This illustrates the importance we attach to these issues in our decision-making. The year 2024 was particularly rich in concrete progress. ESG considerations are now almost always formally integrated into the supervisory boards of our holdings. We are seeing ESG aspects becoming increasingly important in the compensation structures of the companies in which we invest, as well as the feminisation of their board of executives. As a result, more than 70% of our portfolio companies have at least one woman in their board of executives. In addition, we are seeing numerous announcements of the appointment of CSR managers and the implementation of value creation sharing mechanisms within our investees.

L.L. — This progress is the result of rigorous support, made possible by the customised ESG roadmaps we implement across our entire portfolio. This tool reflects the desire of the companies we support to receive both financial and non-financial support. Our work is based above all on close relationships, listening, and a shared commitment to longterm engagement. This is why we are keen to maintain portfolios on a human-scale, allowing us to stay closely informed of the challenges facing each company.

What are your next challenges?

C.C. — We have a major project underway that will be completed in 2025. It aims to establish a comprehensive carbon footprint for 100% of our investments. More generally, 2025 marks a new phase in our ESG strategy: after structuring, comes the time to demonstrate our effectiveness.

Our role as a trusted partner is to support our portfolio companies towards sustainable growth, which must be ESGfocused. This award recognises our resolutely forwardlooking strategy.

Bringing ESG to life on a daily basis at ARA: a word from the Front Runners

As a community of committed players in responsible investment, the ESG Front Runners are on a mission to advance ESG culture at all levels of ARA. Through concrete actions and discussions, they educate and raise awareness among teams in a pedagogical manner. Meet three new recruits: Laure Dall Ava, Tennessee Petitjean and Natasha Franks.

What is your role as Front Runners?

Natasha Franks — Our mission is to build bridges between our areas of expertise, and to facilitate and promote dialogue between the different ARA teams on major ESG topics. The objective is for everyone to understand how these topics impact their business, as well as the opportunities associated with them.

Tennessee Petitjean — This translates into discussion sessions prepared by Front Runners from a wide range of areas of expertise. This diversity reflects the essence of the project: encouraging synergies between teams to create innovative solutions. This openness is reflected in the choice of topics we cover and the diversity of participants, from managers to compliance and communication.

How did this translate in 2024?

Laure Dall Ava — Four internal meetings were organised over the past year: focusing in particular on the CSRD¹⁰, which requires companies to publish sustainability reports, or on the CS3D¹¹, which introduces stricter due diligence requirements for supply chains. We analysed these two European regulations, which were at the forefront of the news at the time, and answered numerous questions from the investment and management teams. This proved particu-

larly useful for employees who were less familiar with ESG issues but nevertheless confronted with these topics in their daily work. For example, the asset managers ended up better equipped to advise the companies they support.

N.F. — These are good examples of how the Front Runners format is focused on collective thinking and addresses the highly operational challenges facing our portfolio management teams, as well as those facing our portfolio companies. The idea is also that these discussions and the solutions that emerge from them will feed into our future strategies, in line with ARA's ESG Ambitions 2025 plan.

Did you encounter any difficulties?

T.P. — No obstacles, on the contrary, the movement is enjoying growing success internally, which encourages us to go further. But challenges yes! Because our desire to create synergies between areas of expertise requires greater cross-functionality in order to resonate with an audience with very diverse professional practices, and varying degrees of knowledge about ESG issues. Even though the necessity of responsible investment is obvious, we still need to continue our awareness-raising efforts to collectively gain maturity on the subject.

What are the plans for 2025?

L.D.A. — The coming year will be an opportunity to explore complementary themes that we identify as key to environmental and social issues, such as biodiversity. We want to broaden our scope of reflection even further with the help of external experts. We are also considering ways to formalise these meetings so that we can share them on a larger scale.

Our ambition is to spread ESG culture across all business lines, so that every team actively contributes to meeting the challenges of tomorrow

Educational modules: private markets explained to everyone



Facilitating access to private markets for all requires both the democratisation of a range of investment funds and an increased educational effort for investors.

In 2024, ARA created a series of educational modules, designed to explain the key aspects of private markets to individual investors. These fun resources aim to support advisors and, ultimately, future investors. The first video introduces the main principles of private markets and the reasons for investing in them, followed by a range of modules dedicated to each asset class. To understand a world often perceived as complex due to technical terms, ARA uses an innovative format with an interactive glossary, infographics, self-assessments, and animated videos.  ARA places education and transparency at the forefront of its external communication efforts, diversifying formats and channels to reach an increasingly wider audience.

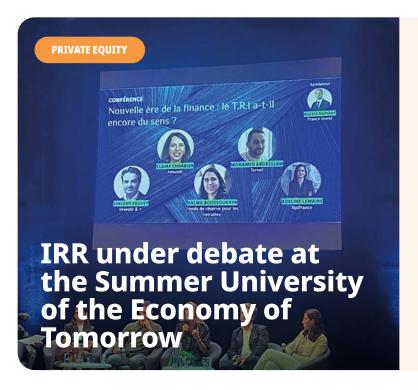

This podcast gives a voice to investors and fund managers who share a vision of ESG and impact, allowing them to discuss their experience and the challenges specific to their asset classes, whether it is private equity

or venture capital. In this episode, Natasha Franks discussed the principles, challenges, and drivers of the ESG reporting approach applied to Amundi Alpha Associates' products across private equity, private debt, and infrastructure. The podcast was a useful initiative to better understand the evolution of ESG and impact investing in private markets.

ESG reporting has become a priority for European asset managers. It is now considered a "must have" for investors. Today, there is a broad consensus that strong ESG practices are essential to ensure investments align with sustainability goals.

The IRR - or Internal Rate of Return - remains a benchmark indicator for measuring the profitability of an investment, taking into account all financial flows over its lifetime.

Essential in private equity for comparing performance, it nevertheless raises questions at a time of major transitions. Can it be enough to assess a company's performance in a world facing the climate and social emergency? On June 28, 2024, during the Summer University of the Economy of Tomorrow, an annual event that brings together decision-makers and investors to collectively rethink the role of finance in current transitions, Claire Chabrier, Managing Partner at Amundi Private Equity Funds (PEF), took part in a round table discussion entitled "A new era of finance: does IRR still make sense?" Alongside representatives from the FRR, Bpifrance and Investir&+, Claire Chabrier emphasised the importance of broadening our conception of performance by incorporating rigorous, shared and transparent extra-financial criteria. This is a way of aligning performance, sustainability and responsibility.

Impact Master Class: the **foundations** of real impact

 On September 18th, 2024, Amundi Alpha Associates presented the masterclass "Unlocking Impact: Best practices in impact fund management" to UK institutional investors in London.

The event was organised by Pensions for Purpose, a UK-based organisation that supports institutional

investors in integrating sustainability and impact into their strategies. The interactive masterclass provided insights into sourcing appropriate impact managers, setting impact strategies, and developing a Theory of Change, alongside effective measurement and verification. Its objective was to better define what characterises an impact fund. The discussion emphasised key criteria such as a clear investment thesis, recognised frameworks (e.g. SDGs, Theory of Change), and the articulation of impact goals and ESG risks, while also highlighting the multi-manager's role in supporting investors to achieve intentional and measurable impact outcomes.

Meaningful impact begins with transparency. Our mission is to make ESG and impact data legible, measurable, and actionable.

INTERVIEW

ESG is part of ARA's DNA: we are not following a trend, we have a longterm vision

In a turbulent environment, 2024 was a year of consolidation, structuring and reaffirmed commitment for Amundi Alternative & Real Assets. Sandrine Lafon-Ceyral, Chief Responsible Investment at Amundi Alternative & Real Assets, looks back on the major advances made, the rise of ESG expertise within the teams, and the ambitions for 2025.



SANDRINE LAFON-CEYRAL Chief Responsible Investment at Amundi Alternative & Real Assets

In light of the objectives set by the Amundi Group for 2025, how would you assess the year 2024?

If I had to choose one word to sum up our actions in 2024, I would choose "consolidation". Indeed, we have strengthened our methodology and improved the reliability of our tools, particularly for data collection and analysis. The ESG team dedicated to ARA has been expanded with three new experienced specialists, which now allows us to have an ESG expert for each area of expertise, a valuable asset for supporting projects on a very close and operational basis. This structure strengthens our ability to combine performance requirements and responsibility within each area of expertise.

Another significant milestone and source of pride is the launch of several funds, which you have been able to discover throughout these pages. Through their ambitious strategies, they are a concrete expression of our commitment to responsible investment. These include the AMUNDI PRIMA investment programme, Amundi Private Equity Transition Juste, certified TIBI and Greenfin, or Amundi Ambition Agri-Agro, supported by a scientific committee. These achievement come on top of the recognition we received with the ESG Sustainable Development award presented to Amundi PEF by Private Equity Magazine, as well as the renewal of our SRI labels in real estate.

These achievements demonstrate significant progress in the integration of ESG criteria at all levels of our businesses.

How has the perception of responsible investment changed in recent years?

The days when ESG considerations were viewed by the entire financial ecosystem as a non-essential extra are now over in Europe. At ARA, thanks to our selection policy, ESG considerations are now fully integrated into our processes. Industry players, both companies and investors, are demonstrating a genuine desire to move forward together. While there is still room for improvement, particularly with regards to the carbon footprint of our investments, ESG remains, more than ever, a cornerstone of our investment solutions and support services. This is a key milestone of which we are collectively proud.

These moments of discussion fuel our thinking, create commitment, and also very concretely feed into our projects.

And internally, how is the subject being taken up by the teams?

We have built a community of committed employees within each of ARA's areas of expertise, the Front Runners, which now consists of about thirty talented volunteers.

Their mission? To collectively reflect on and master the key ESG issues for our sector.

In 2024, we trained all relevant employees on ESG topics, including regulations. This groundwork will allow us to open up our initiatives to collective reflection in 2025 to address broader and more structural issues.

What are the priorities for 2025?

The next few months will be dedicated to the larger-scale deployment of the collection and processing of data necessary to carry out the carbon footprint assessment of all the companies we support, so that we can have a complete vision for all our areas of expertise and thus better manage our medium- and long-term strategy and support our companies in the construction and implementation of their decarbonisation pathway.

We are also planning several thematic sessions with the Front Runners, led by an expert-manager duo with the aim of expanding the range of possible projects under consideration. We will address biodiversity, water resource management and human factors, three essential themes that we wish to focus on more in 2025. The contribution of external specialists will be crucial to ensure a differentiated approach to these issues. Our goal is to quickly translate these reflections into concrete projects that will have an impact.

Finally, we will continue to share our progress through educational and accessible content, in line with our commitment to transparency and awareness-raising.

Have you encountered any particular challenges this year?

The international context has been marked by a certain setback on ESG issues, with major asset managers distancing themselves from the GFANZ (Glasgow Financial Alliance for Net Zero). In response to these signals, we have collectively reaffirmed our belief that ESG is embedded in ARA's DNA. We are not following a trend, we carry a long-term vision. The withdrawal of certain major players also opens up opportunities: we can strengthen our position in high-potential markets, linked to major transitions. We are convinced that responsible innovation is a strategic lever to sustainably support the companies we support.

Thus, 2024 was the year of reaffirming our deep convictions, in a turbulent global context. It has resulted in a consolidation of our methods and a multiplication of projects and achievements with a positive impact that make our teams proud. True to the ambition of collective progress anchored in our DNA, we are approaching 2025 with determination, in line with our mission and values.

We firmly believe that responsible innovation is a strategic lever for providing longterm support to the companies we work with.

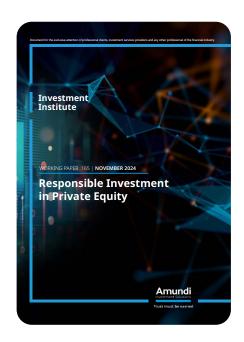

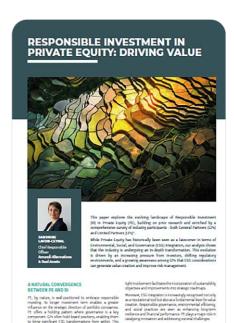
